#### Modifications to RFP:

The following modifications are hereby incorporated into the Request for Proposal identified above and all Bidding Documents:

##### **A. REVISIONS TO SPECIFICATION**

- a. Page 14 of 335; SECTION 004100 Bid Form amended to include additional work items for concrete islands and concrete slab on grade.
- b. Page 16 of 335; Base Bid Cost Breakdown amended to include bonds under Division 01 – General Requirements.
- c. Page 17 of 335; Base Bid Cost Breakdown amended to include Alternate Schedule work item for relocation of existing waterline (if needed) to ensure a minimum 5'-0" cover. Contractor shall be

Page 204 to 335; Technical Section 01 78 39 – Project Record Documents - Part 2 Products, Section 2.1 Record Drawings – C has been amended to include the addition of the following language: Newly Prepared Record Drawings: Prepare new Drawings instead of preparing Record Drawings where Architect determines that neither the original Contract Drawings nor Shop Drawings are suitable to show actual installation. Contractor to perform survey with a licensed surveyor for as-builds after construction.

## **B. REVISIONS TO DRAWINGS**

- a. Page 1 of 9 Cover Sheet; General Notes has been amended to include the addition of Notes 16 – 31.
- b. Page 5 of 9; C-103 - Note 1 has been amended to include the addition of the following language: Refer to driveway profile for slope and additional grading design and grades. Contractor is to verify the existing grade prior to construction.
- c. Page 9 of 9, A-101, Detail 6 “Section @ Centerline of Driveway” - Notes has been amended to include the addition of the following language: All elevations given are taken at the center line of the driveway. Contractor to perform survey to verify all elevations.
